

Minutes of the Fourth Inter Ministerial Board of Certification

The meeting was held on 05.09.2016 under the Chairmanship of Joint Secretary Shri Shailendra Singh. Members from the Department of Science and Technology and the Department of Biotechnology were present. Members of the IMB Secretariat were also present.

2. A list of 33 entities was presented to the Board, of which 32 entities incorporated before 01.04.2016 were found ineligible as per the Finance Act 2016. One partnership firm incorporated after 01.04.2016 was also found ineligible since the Finance Act 2016 provides exemption only for a Company or a LLP. The list of the 33 entities is placed at Annexure 1. The Board was informed that these will continue to be recognized by DIPP as Startups.

3. Twenty one applications of entities incorporated after 01.04.2016 were presented to the Board for consideration of these startups for eligibility for tax benefits. Decision of the Board is as follows
