## Minutes of the 69<sup>th</sup> Inter Ministerial Board

The 69<sup>th</sup> meeting of the Inter-Ministerial Board was held on 09.11.2022 at 3:30 PM over videoconferencing. The meeting was chaired by Smt Shruti Singh, Joint Secretary, Department for Promotion of Industry, and Internal Trade. Dr Rajesh Ghangal, Department of Biotechnology; Dr Sapna Kaushik, Department of Science and Technology; and Dr Sanjeev Majumdar, National Research Development Corporation with his team were present.

One hundred and forty-six cases (146) cases for tax exemption under Section 80-IAC of the Income Tax Act were discussed.

For evaluation of these applications, details of grant of other DPIIT benefits, namely the Startup India Seed Fund Scheme, exemption under Section-56, and National Startup Awards, were also presented by the Technical Agency.

The IMB Secretariat apprised the Board about **SUDRANIA SOFTWARE LLP**, **DIPP45057.** The application of the Startup has been thoroughly examined and it has been found that another entity called "Sudrania Software Private Limited" (Serial Number 111) was formed by the same directors in a similar domain of business. The above-mentioned observations were presented in the IMB meeting and the board has been directed to seek more information on how the Sudrania Software Private Limited services are different from Sudrania Software LLP.
- 114. The IMB Secretariat apprised the Board about **DR SHOPCART PRIVATE LIMITED, DIPP98063.** The application of the Startup was thoroughly examined, and it was found that the Startup is selling electronic gadgets such as headphone, webcam, portable microphone, party speaker etc. at a reasonable discount of up to 60%. The above-mentioned observations were presented in the IMB meeting and the board has directed to seek more reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the Startup. Also, the Startup may clarify whether it is manufacturing these entire products or procuring from other companies.
- 115. The IMB Secretariat apprised the Board about **TRADGEEK FINSOLS PRIVATE LIMITED, DIPP95201.** The application of the Startup was thoroughly examined, and it was found that the Startup is providing trading services for investing in NSE equities, cash as well as F&O and the stock market. The above-mentioned observations were presented in the IMB meeting and the Board has directed to seek more information on whether they have developed an app for this and also more reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the Startup.
- 116. The IMB Secretariat apprised the Board about **DYGTONE SOLUTIONS PRIVATE LIMITED, DIPP75434.** The application of the Startup was thoroughly examined, and it was found that the product of the Startup has not been developed yet also the revenue is nearly zero. The above-mentioned observations were presented in the IMB meeting and the Board has directed them to apply after getting traction in

the market and with more reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the Startup.

117. The IMB Secretariat apprised the Board about ACROSS NODE TRANSIT SOLUTIONS PRIVATE LIMITED, DIPP44762. The application of the Startup was thoroughly examined, and the following observations were found:

The above-mentioned observations were presented in the IMB meeting and the Board has directed to seek more information on the same.

- 118. The IMB Secretariat apprised the Board about J.R.L. ENGINEERING INFRATECH PRIVATE LIMITED, DIPP100914. The application of the Startup was thoroughly examined, and it was found that Startup is a supplier of Medical Instruments. The above-mentioned observations were presented in the IMB meeting and the Board has been directed to seek more information whether it is manufacturing these entire products or procuring from other companies.
- 119. The IMB Secretariat apprised the Board about **DEFENDER MEDIA PRODUCTION LLP, DIPP110118.** The application of the Startup was thoroughly examined, and it was found that the Startup is providing HR consultancy services. The above-mentioned observations were presented in the IMB meeting and the board has directed to seek more reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the Startup.
- 120. The IMB Secretariat apprised the Board about **XAME GLOBAL PRIVATE LIMITED, DIPP98952.** The application of the Startup was thoroughly examined, and it was found that the Startup is a service provider for foreign companies for their work such as preparation of completion reports, preparation of files etc. The above-mentioned observations were presented in the IMB meeting and the board has directed to seek more reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the Startup.
- 121. The IMB Secretariat apprised the Board about **RDT TECHNOLOGY PRIVATE LIMITED, DIPP79786.** The application of the Startup was thoroughly examined, and it was found that 'Mr. Aditya Ranjan Sinha Roy' (having 50% shareholding) is also a 50% shareholder in 'ARSR Technologies Private Limited'. The abovementioned observations were presented in the IMB meeting and the Board has directed to seek more information on the relationship with ARSR Technologies Private Limited.
- 122. The IMB Secretariat apprised the Board about **ARSR TECHNOLOGIES PRIVATE LIMITED, DIPP88079.** The application of the Startup was thoroughly examined, and it was found that 'Mr. Aditya Ranjan Sinha Roy' (having 50% shareholding) is

also a 50% shareholder in 'RDT TECHNOLOGY PRIVATE LIMITED'. The abovementioned observations were presented in the IMB meeting and the Board has directed to seek more information on the relationship with RDT Technology Private Limited.

123. The IMB Secretariat apprised the Board about AMERICAN CHASE LLP, DIPP104069. The application of the Startup was thoroughly examined, and the following was found:

i. Startup is providing ERP solution. Hence, more reliable information is required which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the Startup.

ii. As per the pitch deck, LinkedIn profile and website, the entity has its headquarters in Portland, Oregon, USA. Thus, the incorporation details of the entity in the USA are required for further evaluation.

The above-mentioned observations were presented in the IMB meeting and the Board has directed to seek more information on the above observations.

- 124. The IMB Secretariat apprised the Board about **TEN QUINTS FINTECH PRIVATE LIMITED, DIPP105085.** The application of the Startup has been thoroughly examined and it has been found that is a consulting firm with a team of qualified professionals such as chartered accountants (CA), lawyers, MBAs, and market analysts. The above-mentioned observations were presented in the IMB meeting and the board has directed to seek more reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the Startup.
- The IMB Secretariat apprised the Board about HONE STRUCTURAL HEALTH 125. MONITORING (INDIA) PRIVATE LIMITED, DIPP101441. The application of the thorouahlv examined. and Startup was it was found that the shareholders/directors- Purushottam Nandlal Varma and Mahesh Nandalal Varma are associated with a company 'Nandadeep Designers & Valuers Private Limited' (incorporated since 1988) and is providing structural consultancy and is working in the same projects as mentioned in the pitch deck of the applicant company. The above-mentioned observations were presented in the IMB meeting and the Board has directed to seek more information on the above observations.
- The IMB Secretariat apprised the Board about STARSHINE BRANDS PRIVATE 126. LIMITED, DIPP102013. The application of the Startup was thoroughly examined, and it was found that the Startup is in the hospitality business and offers brand franchising for fusion restaurants and bars under several brand names Aviary, Ivorry, Drops Beach Bar. The above-mentioned observations were presented in the IMB meeting and the board has directed to seek more reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered the Startup. by

127. The IMB Secretariat apprised the Board about **FIORELLO TECHNOLOGIES PRIVATE LIMITED, DIPP57973.** The application of the Startup was thoroughly examined, and the following was found:

i. As per the clarification submitted, the entity is a recruitment consulting firm. However, earlier the company was building an Ed-Tech SaaS platform. The website of the entity is under development.

ii. The information on the pitch deck is not sufficient to verify the details provided.

iii. Lack of reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the Startup.

The above-mentioned observations were presented in the IMB meeting and the Board has directed to seek more information on the above observations.

- 128. The IMB Secretariat apprised the Board about **KRAYON INFOTECH PRIVATE LIMITED, DIPP48048.** The application of the Startup was thoroughly examined, and it was found that both the directors (Sachin & Renu Jain) are involved with another firm, Essaycom Consulting Services Private Limited which is working in the same domain and incorporated on 29 July 2003. The above-mentioned observations were presented in the IMB meeting and the Board has directed to seek more information on the above observations.
- 129. The IMB Secretariat apprised the Board about **MICROBRIDGE PRIVATE** LIMITED, DIPP46557. The application of the Startup was thoroughly examined, and it was found that the company website mentions that it is headquartered in the USA. The above-mentioned observations were presented in the IMB meeting and the Board has directed to seek more information on the above observations.
- 130. The IMB Secretariat apprised the Board about **KYZER SOFTWARE INDIA PRIVATE LIMITED, DIPP42346.** The application of the Startup was thoroughly examined, and it was found that 'Mr. Manish Baruch' is also involved with another firm 'Pinwheel Technology Private Limited', which is working in a similar sector. The above-mentioned observations were presented in the IMB meeting and the Board has directed to seek more information on the above observations.
- 131. The IMB Secretariat apprised the Board about **ONEOMICS PRIVATE LIMITED**, **DIPP76067.** The application of the Startup was thoroughly examined, and it was found that as per the MoA, 80% of shares are subscribed by the Korean citizens. The above-mentioned observations were presented in the IMB meeting and the Board has directed to seek more information on the above observations and more details on the BIRAC fund received to the Startup, including the sanction letter from BIRAC.

- 132. The IMB Secretariat apprised the Board about **THEDIGIFAC SERVICES (OPC) PRIVATE LIMITED, DIPP76327.** The application of the Startup was thoroughly examined, and the following was found:
  - i. No proof of business details with mentioned clients.
  - ii. Latest balance sheet was not provided.

The above-mentioned observations were presented in the IMB meeting and the Board has directed to seek more information on the above observations.

- 133. The IMB Secretariat apprised the Board about **CITIUSCLOUD SERVICES LLP**, **DIPP46793.** The application of the Startup was thoroughly examined, and it was found that the Startup has not provided complete balance sheet with all notes of accounts from the date of incorporation. The above-mentioned observations were presented in the IMB meeting and the Board has directed to seek more information on the above observations.
- 134. The IMB Secretariat apprised the Board about **CERES FOODS PRIVATE LIMITED, DIPP75763.** The application of the Startup was thoroughly examined, and it was found that as per the MoA, the company "Ceres hospitality Private Limited" (incorporated on 06 June 2013) holds 99.99% shares of the Startup. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup.
- 135. The IMB Secretariat apprised the Board about **WALLFORT ONLINE PROPERTY PLATFORM PRIVATE LIMITED, DIPP39385.** The application of the Startup was thoroughly examined, and it was found that "Mr. Sanjay Parakh holds 50% shares in Wallfort Properties Private Limited, incorporated on 11 December 2003. Mr. Arpit Parakh, relative of Mr. Sanjay Parakh, holds 50% of shares. The applicant Startup and Wallfort Properties Private Limited is working in real estate business. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup.
- 136. The IMB Secretariat apprised the Board about **KEEV LIFESTYLES LLP**, **DIPP87495.** The application of the Startup was thoroughly examined, and it was found that "Mr. Anil Agarwal holds 60% share in SVR Fashions Private Limited (incorporated on 11 January 2005)." The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup.
- 137. The IMB Secretariat apprised the Board about **5D SOLUTIONS INDIA PRIVATE LIMITED, DIPP66081.** The application of the Startup was thoroughly examined, and it was found that 99.99% shares are subscribed by 5th Dimension Smart Applications Limited incorporated in Jordan. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup.
- 138. The IMB Secretariat apprised the Board about **PADMAWATI ORNAMENTS PRIVATE LIMITED, DIPP78656.** The application of the Startup was thoroughly examined, and it was found that the Startup is working in the traditional business of jewellery. The above-mentioned observations were presented in the IMB

meeting and the Board has not recommended the application of the Startup due to lack of reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the Startup.

- 139. The IMB Secretariat apprised the Board about **NIHON EDUTECH PRIVATE LIMITED, DIPP63113.** The application of the Startup was thoroughly examined, and it was found that Shareholder "Ms. Anuradha Krishnan and family members" of 'Nihon Edutech Private Limited' have a major shareholding in Zunotech Edusystems Private Limited (established since 2007) which is working in similar domain i.e., education and software service provider. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup.
- 140. The IMB Secretariat apprised the Board about JUDICIAL ADDA ONLINE PRIVATE LIMITED, DIPP102266. The application of the Startup was thoroughly examined, and it was found that Startup is providing online classes for competitive exams such as CLAAT, NET-JRF, judicial services etc. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup due to lack of reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the Startup.
- 141. The IMB Secretariat apprised the Board about **NIYOTO TECHNOLOGIES PRIVATE LIMITED, DIPP93451.** The application of the Startup was thoroughly examined, and it was found that as per the MoA, 32% of shares are subscribed by Gigamodules Software Services LLP (Incorporated in 2012). The abovementioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup.
- 142. The IMB Secretariat apprised the Board about **JUVENOR HEALTHCARE PRIVATE LIMITED, DIPP92277.** The application of the Startup was thoroughly examined, and it was found that the Startup is in a license agreement with Aditya Birla Fashion & Retail for Manufacturing, sales and distribution of licensed products (sanitiser, deodorants, vegetable and fruit wash, men's groom wash) for its brand Peter-England. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup.
- 143. The IMB Secretariat apprised the Board about **POOJA BEAUTIFULLY YOURS PRIVATE LIMITED, DIPP103171.** The application of the Startup was thoroughly examined, and it was found that Startup is an online jewellery store, and the website mentions the commencement of business of selling jewellery since 1929. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup.
- 144. The IMB Secretariat apprised the Board about **KNITROOT INDIA PRIVATE LIMITED, DIPP96552.** The application of the Startup has been thoroughly examined and found that Startup is online seller of knitted cloths. The abovementioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup due to lack of reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the Startup.

- 145. The IMB Secretariat apprised the Board about **TATKAL LOAN INDIA PRIVATE LIMITED, DIPP66714.** The application of the Startup was thoroughly examined, and it was found that the Startup is engaged in providing loans to their customers against tangible property, business loans, and personal loans and charging a fixed amount of interest depending upon the requirement of loans. The abovementioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup.
- 146. The IMB Secretariat apprised the Board about CHARLES WALTERS COUNCIL FOR INNOVATION AND RESEARCH, DIPP97739. The application of the Startup was thoroughly examined, and it was found that the entity is an NGO / a society that strives to empower and support every learner in the domains of innovation and research by providing a platform for guidance in writing a thesis and research proposal writing, personality grooming sessions, giving excellency awards etc. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the Startup.
