Minutes of the Twenty Seventh Inter Ministerial Board

- The 27th meeting of the Inter Ministerial Board was held on 31.07.2018 at 3:00 PM in Room No.
 152, Udyog Bhawan. The meeting was convened by Shri Atul Chaturvedi, Additional Secretary,
 Department of Industrial Policy and Promotion. Representatives from Department of
 Biotechnology, Ministry of Electronics and Information Technology, Ministry of Corporate Affairs,
 Central Board of Direct Taxes, and Reserve Bank of India were present. List of participants is
 enclosed at Annexure 1.
- 2. Three agenda items were taken up for consideration.

3. Item No. 1: One (1) case for exemption under Section 56 of the Income Tax Act

- 3.1. The Board was informed by the IMB Secretariat that one Startup has submitted an application for exemption under Section 56 of the Income Tax Act.
- 3.2. Some members of the Inter Ministerial Board observed the following:
- A Startup entity, having share capital and share premium in excess of 10 Cr is not eligible to apply as per clause 4.(1)(i) of DIPP Gazette Notification G.S.R. 364(E).
- The spirit of the notification extends the benefit of exemption to startups with share capital and premium amount upto Rs. 10 Crore and not beyond.
- For a case to be considered for tax exemption under Section 56, the entire transaction shall be considered. Part consideration of the transaction is not possible.
- 3.3. In view of above, the Board decided to seek clarification from DIPP whether a startup with proposed issue of shares exceeding ten crore rupees may be considered for approval for benefit upto ten crore rupees as per the notification. The concerned application of TAGOS DESIGN INNOVATIONS PRIVATE LIMITED, DIPP2832, was deferred pending a decision on this issue.

4. Item No. 2: Seven (7) cases recommended for exemption under Section 80IAC of the Income Tax Act

- 4.1. Seven (7) applications were recommended to the Board by the technical evaluation agencies for consideration for tax exemption under Section 80 IAC of the Income Tax Act.
- 4.1. 1. The technical agency apprised the Board about KALKI ECOSPHERE LLP, DIPP15187, manufacturers of a patented water purification system. The agency recommended that owing to the innovativeness and scalability of the product, the application may be approved for income tax exemption. The Board deliberated and accepted the recommendation of the technical agency and approved the application for income tax exemption under Section 80 IAC of the Income Tax Act.
- 4.1.2. The IMB Secretariat on behalf of the technical agency apprised the Board about KNOX INNOVATIONS LLP, DIPP8696, manufacturers of an IT enabled 'smart' beverage dispensing

nozzle and management system. The Secretariat recommended that owing to the innovativeness, scalability and high potential for wealth creation, the application may be approved for income tax exemption. The Board deliberated and accepted the recommendation of the Secretariat and approved the application for income tax exemption under Section 80 IAC of the Income Tax Act.

- 4.1.3. The technical agency apprised the Board about UDMA TECHNOLOGIES PRIVATE LIMITED, DIPP9625, developers of a proximity offline digital wallet. The technical agency recommended that owing to the innovativeness, scalability and high potential for wealth creation, the application may be approved for income tax exemption. The Board deliberated and decided that adequate differentiation was not found in regard to similar services available in the market. The startup shall be provided detailed observations for the same on their dashboard and provided 30 days from the date of communication of the observations to reply or accept these observations as reasons for rejection.
- 4.1.4. The IMB Secretariat on behalf of the technical agency apprised the Board about DISRUPTECH SOLUTIONS LLP, DIPP11513, an online platform to share home cooked food, bakery, hand made items and home tuition etc. The application was considered in a previous IMB meeting and revaluated based on its responses against the observations shared by the Board. The Secretariat recommended that owing to the scalability and high potential for employment generation, the application may be approved for income tax exemption. The Board deliberated and did not accept the recommendation. The Board rejected the application for income tax exemption under Section 80 IAC of the Income Tax Act.
- 4.1.5. The IMB Secretariat on behalf of the technical agency apprised the Board about MAGIQUE LIFESTYLES LLP, DIPP12312, manufactures of beauty and health products. The application was considered in a previous IMB meeting and revaluated based on its responses against the observations shared by the Board. The Secretariat recommended that owing to its innovation, scalability and high potential for wealth creation, the application may be approved for income tax exemption. The Board deliberated and did not accept the recommendation. The Board rejected the application for income tax exemption under Section 80 IAC of the Income Tax Act.
- 4.1.6. The IMB Secretariat on behalf of the technical agency apprised the Board about ANVAYAA KIN CARE PRIVATE LIMITED, DIPP6932, aggregator of 360 degree services for elderly. The application was considered in a previous IMB meeting and revaluated based on its responses against the observations shared by the Board. The Secretariat recommended that owing to its scalability and high potential for employment generation, the application may be approved for income tax exemption. The Board deliberated and did not accept the recommendation. The Board rejected the application for income tax exemption under Section 80 IAC of the Income Tax Act.
- 4.1.7. The IMB Secretariat on behalf of the technical agency apprised the Board about WALTERS SIDDHA RESEARCH PRIVATE LIMITED, DIPP15029, providers of medicine for affordable health care. The application was considered in a previous IMB meeting and revaluated based on its

responses against the observations shared by the Board. The Secretariat recommended that owing to its innovation and high potential for wealth generation, the application may be approved for income tax exemption. The recommendation. The Board rejected the application for income tax exemption under Section 80 IAC of the Income Tax Act.

- 5. Item No. 3: One hundred and ten (110) cases not recommended for exemption under Section 80IAC of the Income Tax Act
 - 5.1. One hundred and ten (110) applications of presented to the Board as not recommended for tax exemption under Section 80 IAC of the IT Act. The Board accepted the recommendation. The list of such applications is enclosed at Annexure 2.
 - 5.1.1.Out of these, seventy (70) startups were not recommended for tax benefits under Section 80 IAC of the IT Act due to reasons mentioned in Table 1. These startups shall be provided detailed observations/comments for the same on their dashboard and provided 30 days from the date of communication of the observations to reply or accept these observations as reasons for rejection. The details of the seventy (70) applications to whom observations are to be communicated for response, if any are mentioned in Table 1.
 - 5.1 2. Forty (40) applications considered in the previous IMB meetings were revaluated based on their responses against the observations shared. The same were not found eligible, and hence rejected for tax benefits. The details of the entities are mentioned in Table 2.
