Minutes of the 71st Inter Ministerial Board

- 58. The IMB Secretariat apprised the Board about BALKRUSHNA INFRASTRUCTURE PRIVATE LIMITED, DIPP76808. The application of the startup has been thoroughly examined and it was found that the startup's website has mentioned that the Balkrushna Group has been a founded in 1975 by Shri Balkrushna Vyas for land revenue consultancy and broking services. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup.
- 59. The IMB Secretariat apprised the Board about EVOLUTIVE EONICSLABS PRIVATE LIMITED, DIPP28000. The application of the startup has been thoroughly examined and it was found that both the directors Shri Abhinav Kumar and Shri Manjaree Bhatnagar (holding 50% share each) are foreign nationals of the Netherland since 2018 and 2020 respectively. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the Startup.
- 60. The IMB Secretariat apprised the Board about INGEX FOODS PRIVATE LIMITED, DIPP98907. The application of the startup has been thoroughly examined and it was found that 99% shares are subscribed by Ingex Lab Private Limited that is incorporated on 01 September 2017. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup.
- 61. The IMB Secretariat apprised the Board about ALBATROZ (INDIA) LLP, DIPP55742. The application of the startup has been thoroughly examined and it was found that Albatroz Solutions LLC, USA has been registered in Texas and handles sales paperwork for customers in USA and held majority (51%) partnership on LLP. Albatroz (India) LLP takes care of the delivery of the contracted work for Albatroz Solutions LLC. However, in the clarification submitted on 24 November 2020, Albatroz Solutions LLC (USA) withdrew the capital and ceased to exist as a partner of Albatroz (India) LLP, making the LLP a complete standalone Indian entity. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup.
- 62. The IMB Secretariat apprised the Board about FINNOVUS TECHNOLOGIES PRIVATE LIMITED, DIPP72669. The application of the startup has been thoroughly examined and it was found that 61% of shares are subscribed by Gabhasti Technology Private Limited (incorporated on 05 November 2018). Gabhasti Technology Private Limited is involved in the maintenance of websites of other firms/ creation of multimedia presentations for other firms etc. The abovementioned observations were presented in the IMB meeting and the board has not recommended the application of the startup.
- 63. The IMB Secretariat apprised the Board about DMAIC INNOVATIONS PRIVATE LIMITED, DIPP27814. The application of the startup has been thoroughly examined and found that DMAIC Technologies is a partnership firm set up in February 2016 by the promoters of DMAIC Innovations Private Limited to do the business of consultancy, engineering, and installation & commissioning of storage silos. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup.

- 64. The IMB Secretariat apprised the Board about MIRISTAN CONSULTING AND SERVICES (OPC) PRIVATE LIMITED, DIPP51749. The application of the startup has been thoroughly examined and it was found that as per the website and pitch deck submitted, Miristan Travel Technology Private Limited was incorporated in Jan 2014. The company is engaged in Trade with Russia. The entity is incorporated in 2019 and provides services to exporters, farmers, small businesses from their pan Russia database. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup.
- 65. The IMB Secretariat apprised the Board about KRAFTPIXEL DIGITAL SOLUTIONS PRIVATE LIMITED, DIPP55901. The application of the startup has been thoroughly examined and it was found that as per clarification submitted, the company was registered as proprietorship entity in 2014 which is still active and registered on the name of Sulbha Gharat. The proprietorship's name is Kraftpixel. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup.
- 66. The IMB Secretariat apprised the Board about FEMTECH FERTILITY DOST PRIVATE LIMITED, DIPP28702. The application of the startup has been thoroughly examined and it was found that the startup is offering a platform for counselling couples on fertility related issues like personalised diet plans, ayurveda, meditation, yoga, acupressure, doctor matching. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup due to due to lack of reliable information which can ascertain innovation of the product/ services offered by the startup.
- 67. The IMB Secretariat apprised the Board about JACKINTHEBOX TOYS PRIVATE LIMITED, DIPP57703. The application of the startup has been thoroughly examined and it was found that one of the shareholders, Mudita Todi, holds citizenship of Bangladesh. The shareholder has 2400 shares out of total shares of 10,865. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup.
- 68. The IMB Secretariat apprised the Board about FRENCH CROWN PRIVATE LIMITED, DIPP103632. The application of the startup has been thoroughly examined and it was found that startup is offering an online store for Men's Premium Clothing. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup due to lack of reliable information which can ascertain innovation and improvement of the product/ services offered by the startup.
- 69. The IMB Secretariat apprised the Board about TRANSPARENT & TRUSTWORTHY EDUCATION MANAGEMENT SERVICES LLP, DIPP63081. The application of the startup has been thoroughly examined and it was found that startup is providing consultancy services related to education abroad like visa filing, IELTS & GRE guidance, etc. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup application of the startup due to lack of reliable information which

can ascertain innovation and improvement of the product/ services offered by the startup.

- 70. The IMB Secretariat apprised the Board about PRESTINE BROADCASTERS PRIVATE LIMITED, DIPP102222. The application of the startup has been thoroughly examined and it was found that startup has developed a local digital news channel called as "True Scoop". The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup application of the startup due to lack of reliable information which can ascertain innovation and improvement of the product/ services offered by the startup.
- 71. The IMB Secretariat apprised the Board about THAELY PRIVATE LIMITED, DIPP107541. The application of the startup was thoroughly examined, and it has been found that as per the pitch deck, Matteo Pio Sandro Boffa (Swiss citizen) holds 36.96% shares and Globo Media Dws LLC (Country of Incorporation: UAE) holds 5.44% shares. The above-mentioned observations were presented in the IMB meeting and the board has not recommended the application of the startup.
