Minutes of the 70th Inter Ministerial Board Meeting

The 70th meeting of the Inter-Ministerial Board was held on 25.11.2022 at 03:30 PM over videoconferencing. The meeting was chaired by Smt Shruti Singh, Joint Secretary, Department for Promotion of Industry, and Internal Trade. Dr Rajesh Ghangal, Department of Biotechnology; Dr Sapna Kaushik, Department of Science and Technology; and Dr Sanjeev Majumdar, National Research Development Corporation with his team were present.

Eighty-eight (88) cases for tax exemption under Section 80-IAC of the Income Tax Act were discussed.

- 71. The IMB Secretariat apprised the Board about **OMROX GREEN POWER PRIVATE LIMITED**, **DIPP78258**. The application of the startup was thoroughly examined, and the following points were observed:
- a. As per the website, the startup is a manufacturer of lead oxide, lead alloys & lead alloy since 1987 in Gurgaon, Haryana
- b. Website of the entity is not operational.

The above-mentioned observations were presented in the IMB meeting and the board has directed to seek more information about these observations.

72. The IMB Secretariat apprised the Board about **WUNDERBAKED TECHNOLOGIES PRIVATE LIMITED, DIPP25480.** The application of the startup was thoroughly examined, and it was found that the Corporate Identification Number (CIN) of the startup may be incorrect. The above-mentioned observation

- was presented in the IMB meeting and the board has directed to seek more reliable information to check the veracity of the same.
- 73. The IMB Secretariat apprised the Board about MRC CONSTRUCTIONS PRIVATE LIMITED, DIPP87743. The application of the startup was thoroughly examined, and it was observed that there is lack of reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the startup. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 74. The IMB Secretariat apprised the Board about **GERIZIM TECHNOLOGIES PRIVATE LIMITED**, **DIPP29832**. The application of the startup was thoroughly examined, and it was found that the startup was operating as a proprietorship firm since 2011, for which the certificate has also been submitted. The abovementioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 75. The IMB Secretariat apprised the Board about **FASTWELL ENGINEERING PRIVATE LIMITED, DIPP100877.** The application of the startup was thoroughly examined, and it was observed that there is lack of reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the startup. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 76. The IMB Secretariat apprised the Board about **RIVULET DIGITAL PRIVATE LIMITED**, **DIPP94462**. The application of the startup was thoroughly examined, and it was observed that Mr. James William Huebner (Director of the company) is based out of United States & has shareholding of 60% in the company. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 77. The IMB Secretariat apprised the Board about **KATHIR SUDHIR AUTOMATION INDIA PRIVATE LIMITED, DIPP106446.** The application of the startup was thoroughly examined, and it was found that the entity was operating as a proprietorship firm since 2014. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 78. The IMB Secretariat apprised the Board about **PINSOFTEK LLP, DIPP30134.** The application of the startup was thoroughly examined, and as per their website and pitch deck, it has been found that the startup has been offering services since 2000. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 79. The IMB Secretariat apprised the Board about VIRTUAL BUILDING STUDIO PRIVATE LIMITED, DIPP73365. The application of the startup was thoroughly examined, and it was found that the startup has been offering services since 2014 and is headquartered at Houston, Texas. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.

- 80. The IMB Secretariat apprised the Board about **SVIDA MOBILITY PRIVATE LIMITED, DIPP74780.** The application of the startup was thoroughly examined, and it was observed that there is lack of reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the startup. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 81. The IMB Secretariat apprised the Board about **ZONE 4 DISASTER SOLUTIONS PRIVATE LIMITED, DIPP98556.** The application of the startup was thoroughly examined, and it was observed that there is lack of reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the startup. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 82. The IMB Secretariat apprised the Board about **PATELMECH PREQUASINE PRIVATE LIMITED, DIPP83783.** The application of the startup was thoroughly examined, and it was observed on the website that significant contribution made by the entity were recognised during the financial year 2010-11 toward maintaining Leadership in Law Voltage Switchgear in India L & T Limited. The abovementioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 83. The IMB Secretariat apprised the Board about **INSTRON TECHNOLOGIES LLP**, **DIPP71176.** The application of the startup was thoroughly examined, and it was found that the startup was a proprietorship firm since 2013 and has been providing services since 2014. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 84. The IMB Secretariat apprised the Board about **CHOPRA ADVISORY PRIVATE LIMITED**, **DIPP87009**. The application of the startup was thoroughly examined, and it was observed that there is lack of reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the startup. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 85. The IMB Secretariat apprised the Board about **NISHWANTH ENGINEERING PRIVATE LIMITED**, **DIPP102422**. The application of the startup was thoroughly examined, and it was found that Mr. Gunvantbhai Nanjibhai Sherasiya, father of Nishi Gunvant Sherasiya holds shareholding in Unique Forgings (India) Private Limited and Shradha Forge Private Limited, which has a similar product line and are leading manufacturers of high-quality forged products for over 34 years. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 86. The IMB Secretariat apprised the Board about **SCRIBE EMR SYSTEMS PRIVATE LIMITED, DIPP6472.** The application of the startup was thoroughly examined, and it was found that Anirudh Baheti is a shareholder in multiple companies Focus Comtrade Private Limited, Focus Shares & Securities Private Limited, Mathea Multitrading Private Limited., Focus

- Edumatics Private Limited. Etc, that are all found prior to 2016. Additionally, the shareholders Anirudh Baheti is an NRI and Rhea Trading & Investments Pvt Ltd has a non-residential status in India. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 87. The IMB Secretariat apprised the Board about INTEGRO HOSPITALS PRIVATE LIMITED, DIPP105552. The application of the startup was thoroughly examined, and it was observed that there is lack of reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the startup. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
- 88. The IMB Secretariat apprised the Board about **INSPIRED GROW PRIVATE LIMITED, DIPP109889.** The application of the startup was thoroughly examined, and it was observed that there is lack of reliable information which can ascertain innovation, scope of scalability and wealth generation aspect of the product/ services offered by the startup. The above-mentioned observations were presented in the IMB meeting and the Board has not recommended the application of the startup.
