

The members deliberated upon the process for evaluating the applications and decided to approve eight cases. Five applications were deferred and will be returned to the applicant seeking more information and clarification on the details of proof of innovation/ scalability/ improvement/ wealth creation or employment generation.

The meeting ended with a vote of thanks.




