

Minutes of the Tenth Inter Ministerial Board of Certification

The meeting was held on 09.06.2017 under the Chairmanship of Joint Secretary, Department of Industrial Policy and Promotion, Shri Rajiv Aggarwal. Representatives from the Department of Science and Technology, the Department of Biotechnology and Ministry of Electronics and Information Technology were present. Members of the IMB Secretariat were also present. The list of participants is enclosed (Annexure 1).

2. Seventy-two (72) applications of entities incorporated after 01.04.2016 were presented to the Board for consideration of these startups for eligibility for tax benefits.
